## REAL PROPERTY (AMENDMENT) ORDINANCE 1980

### Short title

1. This Ordinance may be cited as the *Real Property (Amendment) Ordinance 1980*.<sup>1</sup>

### Principal Ordinance

2. In this Ordinance, "Principal Ordinance" means the *Real Property Ordinance 1925*.<sup>2</sup>

### Commencement

3. This Ordinance shall come into operation on 1 July 1980.

### Registrar may require map to be deposited

4. Section 64 of the Principal Ordinance is amended by omitting from subsection (1) "the registry office" and substituting "the office of the Registrar".

### Eighteenth Schedule

5. The Eighteenth Schedule to the Principal Ordinance is amended—

- (a) by omitting "14" from the Third Column of Item 1 and substituting "20";
- (b) by omitting "14" from the Third Column of Item 2 and substituting "20";

- (c) by omitting "14" from the Third Column of Item 4 and substituting "20";
- (d) by omitting "14" (wherever occurring) from the Third Column of Item 6 and substituting "20";
- (e) by omitting "14" from the Third Column of Item 7 and substituting "20";
- (f) by omitting "14" from the Third Column of Item 8 and substituting "20";
- (g) by omitting "14" from the Third Column of Item 10 and substituting "20"; and
- (h) by adding at the end thereof the following items:
 

"11	For furnishing a copy, other than a certified copy, of a registered grant or certificate of title	2
12	For furnishing a copy, other than a certified copy, of an instrument previously lodged at the office of the Registrar	1
13	For furnishing a copy of a map or plan previously deposited at the office of the Registrar	0.50"
