An Ordinance to amend the Water Rates Ordinance 1959

Application

- 4. (1) The amendments of the Principal Ordinance effected by Part 1 of the table in section 3 apply to and in relation to rates imposed in respect of the rating year that commenced on 1 July 1982 and each subsequent rating year.
- (2) The amendments of the Principal Ordinance effected by Part 2 of the table in section 3 apply to and in relation to rates imposed in respect of water supplied to a parcel of land in the first meter reading period that ends after 30 June 1983 and in each subsequent meter reading period.
