# **Workers Compensation (Terrorism) Amendment Act 2012**

An Act to amend the Workers Compensation Act 1951

The Legislative Assembly for the Australian Capital Territory enacts as follows:

### 1 Name of Act

This Act is the Workers Compensation (Terrorism) Amendment Act 2012.

### 2 Commencement

This Act commences on the day after its notification day.

*Note* The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

### 3 Legislation amended

This Act amends the Workers Compensation Act 1951.

(4) However, the *Financial Management Act 1996*, section 53A (Unclaimed trust money) does not apply to the temporary fund.

# 9 Entitlement of insurers to reimbursement from temporary fund Section 228 (2)

(2) However, the insurer is entitled to be fully reimbursed from the temporary fund the insurer's uninsured liability for another act of terrorism that happens not later than 1 year after the day the act of terrorism mentioned in subsection (1) happens.

## 232 Review of payments out of temporary fund

- (1) This section applies if the temporary fund is established under section 227 (1).
- (2) The Minister must review the following not later than 10 years after the day the temporary fund is established:
  - (a) the operation of section 229 (Payments out of temporary fund);
  - (b) the operation of any regulation made under section 230 (1) (b) (Regulations about temporary fund).
- (3) The Minister must present a report of the review to the Legislative Assembly within 6 months after the day the review is started.
