You must provide a copy of your driver's licence or some other form of official photographic identity (to assist you, we will make a copy of your original document of identity for this purpose). You must pay a fee for this police records check at the time of lodging your application for the second-hand dealers licence.

A licence will not be issued to you until the police records check has been returned to us and the Commissioner of Fair Trading, or a delegate of the Commissioner, has approved your application. The Commissioner must be satisfied that you are a "suitable person" within the meaning of the Second-hand Dealers Act 1906, before approving your application.
