1 Name of Act

This Act is the *Appropriation Act 2000-2001 (No 2)*.

2 Commencement

5 This Act commences on the day it is notified in the Gazette.

3 Purposes

This Act is made for the purposes of—

- (a) the *Australian Capital Territory (Self-Government) Act 1988* (Cwlth), sections 57 and 58; and
- 10 (b) the *Financial Management Act 1996*, section 6.

4 Words and expressions used in Financial Management Act

A word or expression used in the *Financial Management Act 1996* has the same meaning in this Act.

15 **5 Meaning of *financial year***

In this Act:

financial year means the year that began on 1 July 2000.
