## Magistrates Court (Amendment) Bill 1991

## A BILL

FOR

## An Act to amend the Magistrates Court Act 1930

The Legislative Assembly for the Australian Capital Territory enacts as follows:

#### Short title

1. This Act may be cited as the Magistrates Court (Amendment) Act 1991.

#### Commencement

- 2. (1) Sections 1, 2 and 3 commence on the day on which this Act is notified in the *Gazette*.
- (2) The remaining provisions commence on a day, or respective days, fixed by the Minister by notice in the Gazette.
  - (3) If a provision referred to in subsection (2) has not commenced before the end of the period of 6 months commencing on the day on which this Act is notified in the *Gazette*, that provision, by force of this subsection, commences on the first day after the end of that period.

#### Principal Act

3. In this Act, "Principal Act" means the Magistrates Court Act 1930.1

#### Interpretation

4. Section 116A of the Principal Act is amended by omitting from subsection (1) the definition of "prescribed offence" and substituting the following definition:

" 'prescribed offence' means-

- (a) an offence against the *Motor Traffic Act 1936* or the *Traffic Act 1937*, being an offence for which a penalty of a fine not exceeding \$500, whether with or without any other penalty, may be imposed; or
- (b) an offence against the Motor Vehicles (Dimensions and Mass) Act 1990, being an offence for which a penalty of a fine not exceeding \$1,000, whether with or without any other penalty, may be imposed.".

#### The First Schedule

5. The First Schedule to the Principal Act is amended by omitting from clause 1 of Form 84 "(or *Traffic Act 1937*)" and substituting ", the *Traffic Act 1937* or the *Motor Vehicles (Dimensions and Mass) Act 1990*".
