A Bill for

An Act to amend the *Agents Act 2003*, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

- 1 **1 Name of Act**
- 2 This Act is the *Agents Amendment Act 2008*.

- 4 This Act commences on the day after its notification day.
- 5 *Note* The naming and commencement provisions automatically commence on
