# **Exhibition Park Corporation Repeal Bill 2009**

## **A Bill for**

An Act to repeal the *Exhibition Park Corporation Act 1976*, and for other purposes

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

- 1     **1       Name of Act**
- 2               This Act is the *Exhibition Park Corporation Repeal Act 2009*.
- 3     **2       Commencement**
- 4               (1) Section 4 and schedule 1, part 1.2 commence on the day after this
- 5               Act's notification day.
- 6               *Note*     The naming and commencement provisions automatically commence on
- 7               the notification day (see Legislation Act, s 75 (1)).
- 8               (2) Section 3 commences on 30 June 2009.
- 9               (3) Schedule 1, part 1.1 commences on 1 July 2009.
- 10    **3       Legislation repealed**
- 11               (1) The *Exhibition Park Corporation Act 1976* (A1976-1) is repealed.
- 12               (2) All legislative instruments under the *Exhibition Park Corporation*
- 13               *Act 1976* (A1976-1) are repealed.
- 14    **4       Legislation amended—sch 1**
- 15               This Act amends the legislation mentioned in schedule 1.

## **Part 30                      Transitional—Exhibition Park Corporation Repeal Act 2009**

### **300                      Legislation Act, s 84 inapplicable**

- (1) To remove any doubt, the Legislation Act, section 84 (Saving of operation of repealed and amended laws) does not apply in relation to a member of the governing board of the Exhibition Park Corporation.
- (2) However, if a member of the board is a public servant, this section does not affect any right, privilege or liability that the person has as a public servant.
- (3) This section is a law to which the Legislation Act, section 88 (Repeal does not end effect of transitional laws etc) applies.

- 1     **301**         **Transitional regulations**
- 2             (1) A regulation may prescribe transitional matters necessary or
- 3                 convenient to be prescribed because of the enactment of the
- 4                 *Exhibition Park Corporation Repeal Act 2009*.
- 5             (2) A regulation may modify this part (including in relation to another
- 6                 territory law) to make provision in relation to anything that, in the
- 7                 Executive's opinion, is not, or is not adequately or appropriately,
- 8                 dealt with in this part.
- 9             (3) A regulation under subsection (2) has effect despite anything
- 10                elsewhere in this Act or another territory law.
- 11     **350**         **Expiry—pt 30**
- 12                 This part expires 2 years after the day it commences.
