# **Appropriation Bill 2012-2013**

## A Bill for

An Act to appropriate money for the purposes of the Territory for the financial year beginning on 1 July 2012, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

2		This Act is the Appropriation Act 2012-2013.
