### **Disability Services Amendment Bill 2018**

### A Bill for

An Act to amend the Disability Services Act 1991

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1	Name of Act
	This Act is the Disability Services Amendment Act 2018.
2	Commencement
	This Act commences on the day after its notification day.
	Note The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).
3	Legislation amended
	This Act amends the <i>Disability Services Act 1991</i> .

Part 3	Official visitors
	Note At least 1 official visitor must be appointed for this Act under the Official Visitor Act 2012 (the <b>OV Act</b> ).
	The OV Act sets out the functions of official visitors which includes visiting visitable places, handling complaints from entitled people and reporting on those matters.
	This part defines what is an <i>entitled person</i> and a <i>visitable place</i> for the OV Act. This part also prescribes other matters for the OV Act.
