SIGNIFICANCE/REMARKS

Musician. Founder of Musica Viva Australia, this country's principal chamber music network and one of its most important concert-giving organisations. A musician and professional inventor whose contributions to the equipment of allied services were acknowledged in official accounts of WWII, he was one of the refugees from Nazidominated central Europe. Bringing with him wide experience as a professional violinist and viola player in Vienna and other centres, he was a driving force in the post war inauguration of a Musica Viva Society with its own chamber. music ensemble.

Musician; born London. Pianist, organist, composer, teacher, adjudicatior and critic, he had much to offer when he came to Brisbane as the first director of the Queensland Conservatorium of Music, 1956-59. He published more than 30 text books on rudiments, harmony, counterpoint, orchestration and musical history. He was appointed chief music critic of the Courier Mail in 1959-81.

SIGNIFICANCE/REMARKS

Musician, born Ratcliff London. He went with his parents to to New South Wales in infancy and had his first musical tuition at Newcastle. He began to study music with William John Cordner and joined the orchestra of the Victorian Theatre as a violinist. He was appointed choir master at St Mary's Cathedral, 1872; and organist in 1874; he joined the Lyster Opera Company in Melbourne as Chorus master, 1877. He was a composer of considerable output, producing two masses, many motets and a cantata, 'Captain Cook', to words by P.E. Quinn. His 'Song of the Commonwealth', composed for the swearing-in of Lord Hopetoun as Governor-General in 1901, was reissued in 1951; his most important contribution to Australian music was as a conductor.

Pianist. Born Sydney. Studied piano with Joseph Kretschmann, Sydney 1896; Leschetitsky, Vienna, 1898; taught and performed in Paris; returned to Australia, 1903; performed at the Sydney Town Hall 1904; taught at the NSW Conservatorium; decorated by the French Government with Croix Rouge Francaise for concert work for the Red Cross, 1914-15.

SIGNIFICANCE/REMARKS

Musician. One of Australia's greatest jazzmen, playing the trombone for almost 40 years. Best remembered for his band the Jazz Preachers established in 1958. Established the Vic Jazz Club in 1956.

Musician. Born Bohemia. He arrived in Melbourne, 1880 as a member of Wildner's Strauss Austrian Band; imported for the International Exhibition. When the band broke up in Sydney, he went to Rockhampton, Queensland, in 1885 to teach music under the name Louis D.Hage. In February 1887 he made his debut as conductor of the Rockhampton Philharmonic Society and next year took over the Orpheus Club Orchestra. In twenty five years he made it Queensland's best orchestra though he never had more than twenty two players. He moved to Sydney in 1912 and began taking work in various professional groups, including Cyril Monk's Austral String Quartet and the New Conservatorium Orchestra.

SIGNIFICANCE/REMARKS

Musician. Born Cheshire, England. From 1878 he was organist and choirmaster at Anderson Parish Church, Glasgow. From 1882 he studied music at Queen's College, Cambridge. He was appointed foundation Professor of Music at the University Of Adelaide and arrived there in March 1885. The University persuaded the Adelaide City Council to appoint him City Organist, a position he held in 1885-90. He was a prolific composer, especially of songs and works for the organ. He settled in Melbourne where he taught music in Collins Street until 1920 and then at Brighton.


