## BUSINESS FRANCHISE (TOBACCO AND PETROLEUM PRODUCTS) ACT 1984

#### **DETERMINATION OF FEES**

### No. 146 of 1995

Under section 44A of the *Business Franchise (Tobacco and Petroleum Products)*Act 1984, I revoke with respect to all initial and renewed licences that commence on or after 1 November 1995, Determination No. 39 of 1995 which was notified in ACT Special Gazette No. S111 on 30 May 1995, and make the following determination with respect to all initial and renewed licences that commence on or after 1 November 1995.

(1) For the provisions of the Act listed in Column 1 of Table 1, the determined amount per litre for the fuel described in Column 2 of Table 1 shall be the amount per litre set out in Column 3 of Table 1 in relation to those provisions.
