REVOCATION AND DETERMINATION OF FEES

INSTRUMENT No. 133 OF 2001

1. Pursuant to section 6B of the **Scaffolding and Lifts Act 1957** (the Act) I **REVOKE** the Determination No 156 of 2000 dated 8 June 2000 notified in Special Gazette No S20 of 8 June 2000 and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.
