DETERMINATION OF FEES

INSTRUMENT No. 144 OF 2001

- 1. Pursuant to section 78 of the *Water Resources Act 1998* (the Act) I **REVOKE** the Determination No 203 of 1999 notified in Gazette No S51 of 27 August 1999 and Determination No 116 of 2000 notified in Gazette No W17 of 27 April 2000 and Determination No 176 of 2000 notified in Gazette No S20 of 8 June 2000.
- 2. Under I section 78 of the *Water Resources Act 1998* (the Act), I **DETERMINE** that the fees payable for the purpose of those sections specified in Column 1 and described in Column 2 shall be those fees specified in Column 4. These fees are to be paid as described in Column 5.
- Explanatory notes (including the previous year s fee) are included in the Schedule. Explanatory notes are included at the end of the Schedule, where applicable. Headings and explanatory notes in the Schedule do not form part of the determination. (For example: where new fees for 2001-02 are denoted by an N/A in 2000-01, if included in the schedule, would not form part of the determination).
- 4. This Instrument commences on 1 July 2001.
