#### INTRODUCTION

The name of this code is the

Code of Ethics to be Observed by Registered Construction Practitioners.

It is made under section 12 of the Construction Practitioners Registration Act 1998.

It has application to all persons registered under that Act.

Failure to comply with the provisions of this code can result in disciplinary proceedings being instigated under paragraph 20(e) of that Act.

#### OBJECTIVE

The objective of this code is to protect the welfare, safety and health of consumers and the community by:

(i) endeavouring to ensure compliance with relevant legislation and standards, particularly:

- the Building Act 1972;
- the Building Regulations;
- the Building Code of Australia;
- •the *Water* and *Sewage* Act 2000;
- the Construction Practitioners Registration Act 1998;
- the Construction Practitioners Registration Regulations; and
- this code of ethics; and

(ii) setting out requirements for appropriate professional conduct and ethical behaviour for persons registered under the *Construction Practitioners Registration Act 1998*.

#### INTERPRETATION

This code focuses on essential matters and sets out the minimum requirements. It should not however, be narrowly interpreted. It is equally important that the spirit of these principles should govern professional conduct and that all persons registered under the *Construction Practitioners Registration Act 1998* should strive to achieve a level of professionalism in excess of the minimum requirements.

#### ADMINISTERING THE CODE

This code is administered by:

ACT Building, Electrical and Plumbing Control (BEPCON),

a section within the

Planning and Land Management Group (PALM),

of the

ACT Department of Urban Services.

Notification of the adoption of, revocations of, and/or amendments to this code is published in the *Australian Capital Territory Gazette*.

# CODE OF ETHICS TO BE OBSERVED BY REGISTERED CONSTRUCTION PRACTITIONERS

A code under section 12 of the Construction Practitioners Registration Act 1998

#### PROVISIONS

Construction Practitioners registered under the *Construction Practitioners Registration Act 1998* commit themselves to:

- honesty;
- fairness;
- independence;
- competence; and
- respect for the laws in force in the Australian Capital Territory.

In that regard, they shall:

**1.** be dedicated to upholding the public interest of ensuring safe and healthy building work and plumbing and drainage work;

2. deal honestly with, and not make any false or misleading representations to clients, government authorities and the public in general;

**3.** be objective, impartial and free of any conflict of interest in the performance of their duties and not have an "interest" in the work that they are involved with, as set out in section 8 of the *Construction Practitioners Registration*  4. act with due care, competence and diligence in the performance of their duties;

**5.** respect the laws in force in the Australian Capital Territory and not participate in any practice that would constitute or aid and abet any contravention of applicable legislation;

6. ensure that they keep their knowledge up to date in regard to relevant legislation, codes, standards and practices;

7. take reasonable steps to undertake their duties in a timely manner and to satisfy statutory limitations;

**8.** not undertake any work that is beyond his or her competence, expertise or qualifications and, instead, obtain appropriate specialist advice; and

**9.** on cessation of his or her appointment as a certifier in respect of a parcel of land, submit a report within seven days to the Building Controller, of the work done, provided the practitioner is paid the necessary fees as a result of his or her services.
