#### Formula For Short Term Licence Periods

Where

- A full licence is issued or renewed for a period other than five years, or

- A provisional licence is issued or renewed for a period other than three years -The fee payable shall be the five-year fee for a full licence divided by sixty and multiplied by the number of months for which the full or provisional licence is issued or renewed. Any part of a month shall be treated as one month.
