

# Major Events (International Cricket Council Cricket World Cup 2015) Declaration 2015 (No 1)\*

Disallowable instrument DI2015–1

made under the

Major Events Act 2014, s 6 (Major event – declaration)

## 1 Name of instrument

This instrument is the *Major Events (International Cricket Council Cricket World Cup 2015) Declaration 2015 (No 1)*.

## 2 Commencement

This instrument commences on the day after its notification.

## 3 Notice of Important Sporting Event—Act, s 6 (1) and s 7 (1) (a)

The three matches held in Canberra as part of the International Cricket Council (ICC) Cricket World Cup 2015, to be held at Manuka Oval on 18 February, 24 February and 3 March 2015, are declared to be a Major Event.

## 4 Event organiser—Act, s 7 (1) (b)

The organiser of the major event is the Cricket World Cup 2015 Ltd (ACN 162 612 675)

## 5 Proposed date—Act, s 7 (1) (c)

The proposed dates of the major event are:

- (a) Wednesday 18 February 2015 (Afghanistan v Bangladesh);
- (b) Tuesday 24 February 2015 (Zimbabwe v West Indies); and
- (c) Tuesday 3 March 2015 (Ireland v South Africa).

**6 Proposed time—Act, s 7 (1) (c)**

The proposed times of the major event are as follows:

- (a) Wednesday 18 February 2015;
  - (i) From 1:00pm when the gates open; to
  - (ii) 10:15pm when the match is scheduled to finish
- (b) Tuesday 24 February 2015; and
  - (i) From 1:00pm when the gates open; to
  - (ii) 10:15pm when the match is scheduled to finish
- (c) Tuesday 3 March 2015;
  - (i) From 1:00pm when the gates open; to
  - (ii) 10:15pm when the match is scheduled to finish.

**7 Event venue—Act, s 7 (1) (d)**

The proposed location of the venue for the major event is the grounds, including any buildings situated on the grounds, occupied by Manuka Oval, Manuka Circle, Griffith ACT 2603.

**8 When notice is in force—Act, s 7 (1) (e)**

This notice is in force for the period—

- (a) beginning at 12:01am on 18 February 2015, ending 12:01am on 19 February 2015;
- (b) beginning at 12:01am on 24 February 2015, ending 12:01am on 25 February 2015;
- (c) beginning at 12:01am on 3 March 2015, ending 12:01am on 4 March 2015;

**9 Notice given under other provisions—Act, s 7 (1)(f)**

Notice will be given under the following provisions for the event:

- (a) Notice of protected symbol – Act, s 26
  - (i) Protected symbols will be notified for the duration of this instrument.
- (b) Notice of clean zone – Act, s32
  - (i) A clean zone will be notified for the duration of this instrument.
- (c) Notice of ticketing protections – Act, s39
  - (i) Protection of ticketing arrangements will apply for the event.

**10 Meaning of prohibited item—Act, s 12 (1) (b)**

The following items are prohibited in addition to those listed under s 12(1)(a) of the Act:

- (a) tripods, monopods or lenses with a total focal strength of greater than 200mm;

- (b) commercial digital video camera equipment; and
- (c) cameras or other type of photographic or recording devices (of any nature whatsoever and whether capable of capturing still or moving pictures) other than for recreational and personal non-commercial use.
