1 Name of instrument

This instrument is the *Cemeteries and Crematoria (Public Cemetery Fees) Determination 2015 (No 2).*

2 Commencement

This instrument commences on the day after its notification day.

3 Determination of fees

The fee for the goods or service listed in column 1 of Parts 1 and 4 of Schedule 1 is the amount specified in column 3.

4 Payment of fees

A fee listed in Schedule 1 is payable to the Australian Capital Territory Public Cemeteries Authority by the person requesting the goods or service listed.

5 Refunds or credits for surrender of an entitlement to an allotment

If a person has paid a fee for an entitlement to an allotment or crypt and surrenders that entitlement, the person may:

- (a) receive a refund as set out in Part 5 of Schedule 1; or
- (b) be entitled to a reduced fee for the entitlement to another allotment or crypt as set out in Part 6 of Schedule 1, subject to the limits set out in that part.

6 Goods and Services Tax

All fees are GST inclusive.

7 Revocation

This instrument revokes the *Cemeteries and Crematoria (Public Cemetery Fees) Determination 2015 (No 1)* (DI2015-87).

Part 5 Refunds for surrender of an entitlement to an allotment

A person surrendering an entitlement to an allotment may receive a proportion of the fees that they have paid as follows:

| Plaque fee | 100% of payment if no plaque has been installed, otherwise 0% |
| Memorial Permit fee | 100% of payment if no monument has been installed, otherwise 0% |

Note:

Where a surrender of an entitlement will involve the exhumation of a body, permission for the exhumation must first be obtained – see section 23 of the Act.

Part 6 Fees for the transfer of entitlement from one allotment to another

- 1. If a person surrenders an entitlement to an allotment or crypt (*the first entitlement*) in order to transfer exclusive rights to another allotment or crypt in a cemetery managed by the cemeteries authority, they will be credited with 100% of the current fees (or their equivalent) relating to the first entitlement, less
 - (a) for the transfer of entitlement from a standard allotments or ashes allotment to another allotment the miscellaneous service fee (set out in part 3 of the schedule) x 2; or
 - (b) for the transfer of entitlement from one mausoleum crypt to mausoleum another 4% of the original payment.

Note The miscellaneous service fee is an hourly fee.

- 2. The surrender and transfer of entitlement must be concurrent.
- Where components of the fee were not paid those components will not count toward the credit.
