1 Name of instrument

This instrument is the Stock (Minimum Stock Levy) Determination 2018.

2 Commencement

This instrument commences on 1 July 2018.

3 Determination of minimum stock levy

The minimum stock levy is—

- (a) for a small landholding—nil; or
- (b) in any other case—\$46.90.

4 Payment of minimum stock levy

The minimum stock levy is payable to the Territory by a person who, in a financial year, is the occupier of land held under a lease permitting the carrying of stock.

5 Goods and services tax

GST is not applicable to these fees.

6 Dictionary

In this instrument, *small landholding* means—

- (a) a landholding of less than 10 hectares; or
- (b) a landholding that has a stock-carrying capacity of less than 50 Dry Sheep Equivalent.

Note The stock-carrying capacity of a landholding is declared by the Director-General under section 7 of the *Stock Act 2005*.

7 Revocation of former instrument
