TRADE MEASUREMENT (ADMINISTRATION) ACT 1991

DETERMINATION OF FEES AND CHARGES

NO. 204 OF 1996

EXPLANATORY STATEMENT

This Determination revokes Determination No. 71 dated 21 June 1995 and notified in the Australian Capital Territory Gazette No. S147 of 27 June 1995.

The *Trade Measurement (Administration) Act 1991* provides for the administration of the *Trade Measurement Act 1991* and related matters concerning "trade measurement legislation". Trade measurement legislation is defined in section 3 of the Trade Measurement (Administration) Act 1991 as including the Trade Measurement (Administration) Act 1991, Trade Measurement Act 1991, the Weights and Measures (Sale of Bread) Act 1929, and regulations made under these Acts.

Section 12 (1) of the Trade Measurement (Administration) Act 1991 enables the Minister to determine fees for the purposes of trade measurement legislation. Fees have generally been increased by 3% in accordance with the anticipated movement in 1996/97 Consumer Price Index.

The determination increases fees for testing the accuracy of measuring instruments, and certification of approved instruments by Trade Measurement Inspectors. Section 10 of the Trade Measurement (Administration) Act 1991 provides for the owner of instruments to pay a fee for the verification and reverification of instruments under the trade measurement legislation.

The legislation also provides for the licensing of private individuals and companies to certify instruments. It also provides for public weighbridges to be licensed and the determination increases these licence fees in line with the Consumer Price Index.

Minor fees under \$20 are reviewed on a 2 yearly basis. A statement of the old and new fees is attached.
