**DETERMINATION OF FEES**

**Determination No. 120 of 1993**

**EXPLANATORY STATEMENT**

In accordance with an undertaking given to the Standing Committee on Scrutiny of Bills and Subordinate Legislation, this instrument revokes all existing fees determinations under the *Motor Vehicles (Dimensions and Mass) Act 1990*, namely:-

Determination No. 91 of 29 June 1993 published in the ACT Gazette No. S127 of 1 July 1993.

This determination sets fees for the purpose of the *Motor Vehicle (Dimensions and Mass) Act 1990* and has the effect of increasing dimensions and mass permit fees for heavy vehicles. The fees reflect the 1993/94 budget strategy of the Government and are set out below, with previous fees shown in brackets.
