EXPLANATORY STATEMENT

The Trade Measurement Act regulates the retail and service industry by ensuring that goods sold in the market place are correct in respect of volume and weight.

The fees charged under the Act are for the inspection of weighing and measuring instruments and have generally been increased in line with the expected movement in the Consumer Price Index.

The attached schedules detail the fee increases and also introduces a new fee for a certificate of suitability for public weighbridges.

The fees are comparable to those charged in other states of Australia.
