Remuneration Tribunal (Consequential Amendments) Bill 1997

Outline

This Bill makes consequential amendments following the commencement of the *Remuneration Tribunal Act 1995*, which established the ACT Remuneration Tribunal The Tribunal determines the remuneration, allowances and other entitlements for ACT office holders, appointees and Executives in the ACT Public Service

The Remuneration Tribunal (Consequential Amendments) Bill 1997 makes consequential amendments to certain ACT Acts and Regulations by repealing or amending sections that provide for payment of remuneration and allowances to statutory office holders The repealed or amended sections provide that the relevant office holder or appointee is to be paid remuneration as determined by the Commonwealth Remuneration Tribunal, or that remuneration is set either by regulation or by the Commonwealth Remuneration Tribunal In some cases the Minister may determine remuneration

The repeal or amendment of these sections removes references to the Commonwealth Remuneration Tribunal from ACT laws and references to other procedures, such as regulations, used to fix remuneration for persons appointed to statutory offices This means that the Chief Minister may issue an instrument under paragraph 10(1)(w) of the *Remuneration Tribunal Act 1995* giving the Remuneration Tribunal formal authority to exercise jurisdiction in relation to the offices or appointments specified in the instrument

This section is repealed to remove the requirement for remuneration and allowances payable to a member of a treatment assessment panel to be prescribed under the *Drugs* of *Dependence Act 1989* Remuneration and allowances payable to a member of a treatment assessment panel will now be determined under the *Remuneration Tribunal Act 1995*

Electoral Act 1992

This section is repealed to remove the requirement for remuneration and allowances payable to a member of the Electrical Licensing Board to be prescribed under the *Electricity Act 1971* Remuneration and allowances payable to a member of the Electrical Licensing Board will now be determined under the *Remuneration Tribunal Act 1995*

Essential Services (Continuity of Supply) Act 1992

Section 12

This section is repealed to remove the requirement that remuneration and allowances payable to a member of the Essential Services Review Committee be prescribed under the *Essential Services (Continuity of Supply) Act 1992* or by a determination of the Commonwealth Remuneration Tribunal Remuneration and allowances payable to a member of the Essential Services Review Committee will now be determined under the *Remuneration Tribunal Act 1995* The new section reinstates the provision that remuneration and allowances payable to a member of the Review Committee is payable by the service provider

Hotel School Act 1996

This section is repealed to remove the unnecessary provision in the Hotel School Act 1996 for remuneration, allowances and other entitlements payable to a non-executive member of the Hotel School Board to be determined by the Remuneration Tribunal or by an interim determination by the Chief Minister Remuneration, allowances and other entitlements for a non-executive member of the Hotel School Board will now be determined under the *Remuneration Tribunal Act 1995* by an interim determination by the Chief Minister, or by reference to the Remuneration Tribunal by instrument under paragraph 10 (1)(w) of the *Remuneration Tribunal Act 1995*

Magistrates Court Act 1930

This section is repealed to remove the requirement for remuneration and allowances payable to a Magistrate to be determined under the *Remuneration Tribunal Act 1973* of the Commonwealth The new subsection reinstates the provision that the Executive may determine the terms and conditions under which a Magistrate holds office Remuneration and allowances for a Magistrate will now be determined under the *Remuneration Tribunal Act 1995*

Section 10L

This section is repealed to remove the requirement for remuneration payable to a special magistrate to be determined under the *Remuneration Tribunal Act 1973* of the Commonwealth The new subsection reinstates the provision that the Executive may determine the terms and conditions under which a special magistrate holds office Remuneration for a special magistrate will now be determined under the *Remuneration Tribunal Act 1995*

Milk Authority Act 1971 =

This section is repealed to remove the requirement for remuneration and allowances payable to a member of the Milk Authority to be prescribed under the *Milk Authority Act 1971* or by a determination of the Remuneration Tribunal Remuneration and allowances payable to a member of the Milk Authority will now be determined under the *Remuneration Tribunal Act 1995*

National Exhibition Centre Trust Act 1976
