## Health Records (Privacy and Access) (Fees) Determination 2023 (No 1)

## EXPLANATORY STATEMENT

This instrument revokes and replaces the Determination of Fees DI2021-265, notified on 22 November 2021.

This instrument comes into effect on 1 April 2023 and reproduces DI2021-265 except for:

- fees have increased by Wage Price Index of 3.25% (rounded);
- item (a) has been amended to include "Includes search fee and time of birth requests";
- the fee at item (b) i) has been identified as being for a hard copy and two new fees have been added for electronic copies of health records;
- item (f) has been added, which states that no fee is payable for a copy of a record for a patient's continued treatment or care;
- minor numbering changes; and
- the date of effect.

The fees schedule balances the importance of ensuring that fees are not a barrier to accessing health records with the need to ensure service providers receive reasonable reimbursement for the cost of providing access to the health records they hold.
