# Liquor (Fees) Determination 2023

### **Disallowable instrument DI2023-186**

made under the

Liquor Act 2010, section 227 (Determination of fees)

## **EXPLANATORY STATEMENT**

The *Liquor Act 2010* (the Act) regulates the supply of liquor in the ACT. Section 227 of the Act provides that the Minister may determine fees for the Act. The purpose of this instrument is to determine the fees under the Act for the 2023-2024 financial year.

Annual licence fees Item 501 refers to annual fees for licences under section 32A of the Act.

Consistent with section 32A of the *Liquor Act 2010*, the fee determination provides that the fees for a matter at item 501 (annual fees) of the schedule to the fees determination are payable to the Commissioner for Fair Trading. The fees for all other matters are payable to the Territory.

The new determination sets the fees that will apply beginning on 1 July 2023 and repeals the *Liquor (Fees) Determination 2022 (No 2)* DI2022-201. It provides for fee increases in line with annual adjustments to the Wages Price Index (WPI) of 3.75%, rounded down to the nearest dollar for most fees, with the exception of fees that have been consecutively rounded down in previous years by more than \$1.00 in which case have been rounded up to the nearest dollar.

This approach aligns with the 2022 Treasury Guidelines for Fees and Charges.
