AUSTRALIAN CAPITAL TERRITORY LAND TITLES ACT 1925 DETERMINATION OF FEES INSTRUMENT NO. 157 OF 1999

EXPLANATORY STATEMENT

The Land Titles Act 1925 governs the registration of dealings in land and the issue of certificates of title for land in the Australian Capital Territory. In particular, subsection139(1) enables the Minister to determine fees for the purposes of the Act and Schedule 3 specifies the matters in the Act for which a fee may be determined. This Determination revokes Determination of Fees No. 201 of 1998 made on 18 August 1998 and notified in the Australian Capital Territory Gazette No. S189 of 1 September 1998 and determines that the various fees payable under the Act, including fees for lodging, for registration and searching documents pertaining to land, shall be as set out in the schedule to the Determination.

The fees determined for items 1-4, 9-33 & 35-37 have been increased by a margin of 2.5% in accordance with the anticipated movement in 1999/2000 of the Consumer Price Index and with a view to full cost recovery.

The fees determined for items 5 & 7 have been \$10 & \$17 respectively for the last two financial years and are now increased to \$11 & \$18 respectively to reflect Consumer Price Index changes on a biennial basis (1.8% for 1998/99 and anticipated 2.5% for 1999/2000) and with a view to full cost recovery.

The fees determined for items 8 & 34 have been \$10 & \$12 respectively for the last two financial years and are now increased to \$11 & \$13 respectively to reflect Consumer Price Index changes on a triennial basis (1.75% for 1997/98, 1.8% for 1998/99 and anticipated 2.5% for 1999/2000) and with a view to full cost recovery.

The fee determined for item 6, has not been increased as the CPI adjustment is less than 50 cents.
