REVOCATION AND DETERMINATION OF FEES

EXPLANATORY STATEMENT

INSTRUMENT NO. 278 OF 1998

This Determination made under section 80 of the Energy and Water Act 1988 (the Act) introduces new fees following recent amendments to the Building Act 1972 which previously included a hydraulics component.

Plumbing Fees

2

All applications received after 4 January 1999 will be subject to the new plumbing fees. These fees replace the previous plumbing component of building application fees or Other Hydraulics fees in cases where no building work was occuring. The Other Hydraulics fees will apply to applications received but not finalised prior to 4 January 1999.
