DETERMINATION OF FEES

Instrument No. 153 of 1998

EXPLANATORY STATEMENT

This determination revokes Determination No. 129 of 24 June 1997 notified in the ACT Gazette No. S194 of 27 June 1997.

This determination sets fees for the purpose of the *Roads and Public Places Act 1937* and has the effect of increasing the fee from 1 July 1998 for

- (a) the opening up or the breaking of the surface of a carriageway which has a surface of the type set out in Column 1 of Schedule 1 in relation to that type of surface; and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has a surface of the type set out in Column 1 of Schedule 2 shall be the amount set out in a or ascertain in accordance with the formula in Column 2 of Schedule 2 in relation to that type of surface

The fees have been increased by CPI and reflect the 1998-99 budget strategy of the Government. The new fees will take effect from 1 July 1998

For ease of reference the new fees are set out below with previous fees shown in brackets.
