## DOG CONTROL ACT 1975

#### REVOCATION AND DETERMINATION OF FEES

### NO. 84 OF 1995

## EXPLANATORY STATEMENT

Section 40A of the Dog Control Act 1975 ('the Act') empowers the Minister to determine fees for the purposes of the Act.

This determination revokes Determination No. 86 of 1994 published in Gazette S129 of 30 June 1994 and sets fees for:

- registration of a dog;
- replacing a tag or certificate of registration;

- licence for keeping a dangerous dog; return and transport of a dog impounded under the Act; providing a certified copy of a certificate of registration;
- viewing the register; and impounding a dog.

Fees payable under the Act have been reviewed and increased generally in line with the Consumer Price Index. Where a new charge has been determined this is noted in the table.

The fees are set out below, the amounts in brackets are the previous fees.
