## **DETERMINATION OF FEES**

#### NO. 52 OF 1994

### **EXPLANATORY STATEMENT**

This instrument revokes all existing fees determinations under the Motor Traffic Act 1936, namely:-

Determination No. 133 of 24 September 1993 published in the ACT Gazette No. S202 of 24 September 1993.

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees payable for transactions which relate to vehicle permits. Set out below for easy reference are the new fees ( and previous fees) which apply to transactions relating to vehicle permits.

The majority of fees have been increased in line with the Consumer Price Index. There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs. The fees reflect the 1994-95 budget strategy of the Government and will take effect from 1 July 1994.
