INSTRUMENT OF APPROVAL UNDER SECTION 10

Under section 10 of the City Area Leases Act 1936 I PETER HUNT APPROVE of MARY ROSE COUPER ("the Applicant") carrying on the profession trade occupation or calling of VETERINARY SURGEON ("the business") on Block 41 Section 61 Division of DEAKIN known as 69 KENT STREET DEAKIN ("the land") subject to the following conditions relating to the use of the land being observed by the Applicant in carrying on the business -

- that this approval will remain valid only while the Applicant continues to be a bona fide resident of the land;
- 2 that the Applicant will ensure that the conduct of the business does not cause an annoyance a nuisance or danger and is not offensive to any tenants or occupiers of adjoining lands;
- that the Applicant will not erect or permit or suffer to be displayed or erected upon the land or any building thereon any advertising sign or hoarding whatever without the consent in writing of the Interim Territory Planning Authority and the Building Controller;
- that the Applicant will conduct the business strictly in accordance with the application made by the Applicant under section 10 of the City Area Leases Act unless otherwise stipulated in this Instrument;
- that no person other than the Applicant will conduct or in any way carry on the business on the land without the prior approval of the Minister;

- 6 that the Applicant will ensure that all residence and business related vehicles are parked within the confines of the land;
- that the Applicant will not employ more than one assistant for the 7 purpose of conducting or carrying on the business on the land without the prior approval of the Minister;
- that only the downstairs area excluding the self contained flat be 8 used for the conduct of the business;
- that the business will only be conducted on the land between the hours of 8.30 am and 6.30 pm Monday to Friday and 9.00 am and 12.00 noon Saturday;
- 10 that the Applicant will conduct the business strictly by appointment, and that such appointments will be organised to ensure that no more than two clients are in attendance at any one time;
- that no more than two animals shall be retained in the premises 11 overnight and that any animal that needs to stay for observation or treatment will be kept in a soundproofed kennel located inside the premises;
- that all animal faeces and any material contaminated with animal 12 faeces or urine shall be collected daily and disposed of by burial at an approved site and shall not be flushed into a sewer or storm water drain;
- 13 that dead animals or any organ or tissue arising out of surgical extraction or otherwise shall be disposed of by burial or incineration at an approved site or disposal facility;
- 14 that all sharp objects and syringes shall be collected in an ... approved container and disposed of in an approved manner;
- 15 that the veterinary practice shall not affect the amenity of any residence in the locality by way of noise, smell and appearance;
- that this approval will terminate on the THIRTIETH day of SEPTEMBER 16 1990 or on such earlier date as the Minister determines in accordance with condition 17;
- upon any failure to comply with any or all of the foregoing 17 conditions the Minister or his Delegate under the said Act may give written notice requiring the Applicant to show cause within a period of fourteen days why this approval should not be revoked. At the expiration of this period the Minister or his Delegate may revoke the approval.
