


**CASINO CONTROL ACT 1988**

## **ALTERATIONS TO THE APROVED RULES OF THE AUTHORISED GAME OF MINI-BACCARAT**

### **MINI-BACCARAT INDEX**

**Insert** the following in the index list after the reference to section 13

#### **“14. TOURNAMENT PLAY”**

### **MINI-BACCARAT RULES**

**Delete** existing section 13 13

**Insert** the following

“13 13 No player or spectator shall handle any cards used in the game of Mini-Baccarat, unless undertaken in accordance with these rules

**Insert** new section as follows

#### **“14. TOURNAMENT PLAY**

- 14 1 In addition to the rules set out in the preceding paragraphs the rules of this section shall apply only to tournament play
- 14 2 The Casino Surveillance Authority shall approve the conditions of entry and of play for each Mini-Baccarat tournament
- 14 3 Where the conditions of entry and play for tournament play approved under rule 14 2 are inconsistent with the rules set out in the preceding paragraphs the conditions approved under rule 14 2 shall prevail to the extent of the inconsistency for the duration of the tournament
- 14 4 The casino operator may charge an entry fee for the tournament and may retain up to 10% of the total entry fees as an administrative charge The casino operator shall offer the balance of the entry fees as prize money in accordance with the approved conditions of tournament play ”

## **ALTERATIONS TO THE APROVED RULES OF THE AUTHORISED GAME OF PAI GOW**

### **PAI GOW INDEX**

Insert the following in the index list after the reference to section 15

#### **“16. TOURNAMENT PLAY”**

### **PAI GOW RULES**

Insert new section as follows

#### **“16. TOURNAMENT PLAY**

- 16 1 In addition to the rules set out in the preceding paragraphs and following appendices, the rules of this section shall apply only to tournament play
- 16 2 The Casino Surveillance Authority shall approve the conditions of entry and of play for each Pai Gow tournament
- 16 3 Where the conditions of entry and play for tournament play approved under rule 16 2 are inconsistent with the rules set out in the preceding paragraphs and in the appendices, the conditions approved under rule 16 2 shall prevail to the extent of the inconsistency for the duration of the tournament
- 16 4 The casino operator may charge an entry fee for the tournament and may retain up to 10% of the total entry fees as an administrative charge The casino operator shall offer the balance of the entry fees as prize money in accordance with the approved conditions of tournament play ”
