## Land (Planning and Environment) Act Draft Variation No.130 to the Territory Plan and Preliminary Assessment for North Gungahlin Structure Plan 2002

Notifiable instrument NI2002—312

made under the

Land (Planning and Environment) Act 1991, Section 19(1) (Public Consultation)

A draft Variation to the Territory Plan has been prepared by the Planning and Land Management Group (PALM) of Urban Services (incorporating the functions of the ACT Planning Authority), relating to the detailed planning for the future suburbs in North Gungahlin.

**Draft Variation No.130,** if adopted, would redefine the basic land use policy framework and introduce a greater level of detail on the Territory Plan Map for the proposed North Gungahlin suburbs of Bonner, Casey, Forde, Jacka, Moncrieff, Taylor and Part Amaroo and Ngunnawal. The draft Variation also proposes to vary the Written Statement in relation to the B8 and B9 Area Specific Policies and to apply these in strategic locations close to activity nodes such as group and local centres.

A mandatory Preliminary Assessment (PA) is also required. The PA identifies the likely impacts of the proposed policy change on the physical, natural and human environments.

Draft Variation No.130 should be read in conjunction with the Preliminary Assessment and Background Report.

Section 9 of the Land Planning and Environment Act 1991 applies to draft Variation No.130. The draft Variation has interim effect for a maximum period of 1 year commencing on

22 October 2002 and ending on 21 October 2003. During this period, or a period commencing on 22 October 2002 and termination at the expiration of the day before:

- the date the draft Variation comes into effect;
- the date the corresponding plan variation is rejected by the Legislative Assembly; or
- the date the draft variation, or the corresponding plan variation, is withdrawn by the Planning Authority of the Minister;
  whichever is shorter, the Territory, the Executive, the Minister or a
  Territory Authority shall not do any act, or approve the doing of any act that –
- a) would be inconsistent with the Territory Plan, if it were varied in accordance with the draft Variation; or
- b) is inconsistent with the Territory Plan.

Section 11 of the *Land (Planning and Environment) Act 1991* (the Land Act), concerning the Heritage Places Register, does not apply to this proposal.

Although draft Variation No.130 and the Preliminary Assessment are being notified concurrently, they will be processed separately in accordance with the relevant provisions of the Land Act.

In addition, Environment ACT have commenced a review of Action Plan 10 (Yellow Box-Red Gum Grassy Woodlands), concurrent with the release of Draft Variation No. 130. As the development area contains Yellow Box-Red Gum Grassy Woodland, the outcomes of the review of Action Plan 10 will be taken into consideration in finalising the North Gungahlin Structure Plan.
