**Draft variation No. 223** to the Territory Plan has been prepared by the ACT Planning and Land Authority in accordance with Section 19 of the *Land (Planning and Environment) Act 1991* (the Act).

The draft plan variation proposes to add a Sport and Recreation Reserve – Public Land (Ph) Overlay in order to make the Lakeside Leisure Centre (Proposed Block 8 of Section 55 Greenway) and the Enclosed Sportsground (Proposed Block 13 Section 46 Greenway) at Tuggeranong, public land reserved for the purposes of a Sport and Recreation Reserve.

Copies of written comments received, and any response from the National Capital Authority, will be made available for public inspection at the ACTPLA Customer Service Centre, 16 Challis Street, Dickson, during normal office hours for a period of 15 business days after the closing date for comments.

Under section 9 of the Act this draft plan variation has interim effect until 30 January 2005 or earlier if:

- the draft variation comes into effect; or
- the approved plan variation is rejected by the Legislative Assembly; or
- the draft variation is withdrawn.

Interim effect means that the provisions of the draft plan variation are to be treated as though they were actually part of the Territory Plan. Where there is an inconsistency between a provision of the draft plan variation and a comparable provision in the Territory Plan, the more onerous provision shall apply.

Section 11 of the Act does not apply because the variation does not vary the heritage places register.
