I am writing in response to your letter dated 14 July 2003, regarding the extension to the Aboriginal and Torres Strait Islander Trilateral Housing Agreement between the Aboriginal and Torres Strait Islander Commission (ATSIC), the ACT Government and the Commonwealth Department of Family and Community Services (FaCS).

ATSIC agrees with the proposed extension of this Agreement to 30 June 2004. This is in line with a decision at the Queanbeyan Regional Council meeting number 38 in Jervis Bay Territory, decision number 1164 whereby Council endorsed the extension of the Tri-lateral Housing Agreement for a further period of 12 months. This will allow for the full establishment of the Steering Committee and enable some development under the terms of the Agreement. It also permits the Steering Committee to review the Agreement and evaluate aspects that may require more detail and/or flexibility.

The Queanbeyan Regional Council considers housing to be a priority within this Region including the ACT. This Council fully supports the Trilateral Housing Agreement and believes this Agreement will move towards better accommodating Aboriginal and Torres Strait Islander residents of the ACT.

Thank you for your letter of 14 July 2003 regarding an extension to the ACT Aboriginal and Torres Strait Islander Trilateral Housing Agreement.

I understand there has been limited progress in implementing the Agreement and in establishing the structures to ensure joint planning arrangements for Indigenous housing programs take place. However, I am informed that officers from the various agencies are now meeting in order to progress the process.

I agree with your suggestion that, in the circumstances, the current Agreement should be extended to 30 June 2004 and, as a Party to the current Agreement, my formal approval is hereby given.

I would also like to raise a related issue and that is the impact on the ACT Housing Agreement of the separation of powers and roles between the Aboriginal and Torres Strait Islander Commission and the Aboriginal and Torres Strait Islander Services (ATSIS). As you will appreciate, this decision will require changes to all State and Territory Indigenous Housing Agreements in order to reflect the roles and responsibilities of ATSIS.

At this stage, officers from the Housing and Environment Branch of ATSIS are developing a proposal to present to the Parties of all Housing Agreements for their approval. I do not anticipate that there will be any difficulties with this process and I understand that the changes can be effectively enacted by an addendum to the Agreement. I am informed that ATSIS officers will be contacting the officers of the agencies who are Parties to the ACT Indigenous Housing Agreement once they have clarified the new roles and responsibilities.
