### 1 Name of instrument

This instrument is the Radiation (Council Decision) Notice 2007 (No 3).

### 2 Commencement

This instrument commences on the day after notification.

### 3 Notice of Decisions

The particulars of decisions of the Radiation Council are as stated in the schedule.

### 4 Right of Review

Any persons whose interests are adversely affected by these decisions may apply to the ACT Administrative Appeals Tribunal to have the decision reviewed. Within 28 days from the commencement of this notice on the Legislation Register, write explaining the details of the decision and the reasons for asking for a review. To lodge an application there is a fee. You may apply to have the fee waived on the grounds of hardship. No fee is payable if you are receiving legal assistance. The Tribunal is located at the ACT Magistrates Court Building, Knowles Place, Canberra City, GPO Box 370 Canberra City ACT 2601, Telephone (02) 6217 4261, Facsimile (02) 6217 4505, Document Exchange DX 5691. The Tribunal is an independent body. The Tribunal can agree with, change or reject to the original decision, substitute its own decision or send the matter back to the decision maker for reconsideration in accordance with Tribunal recommendations.

### 5 Reasons

If you wish to obtain a statement of reasons to explain why the decision was made you should write within 28 days of this notice on the Legislation Register, to the ACT Radiation Council, GPO Box 825, Canberra ACT 2601.
