## 1 Name of instrument

This instrument is the *Taxation Administration* (Notice of tax in arrears) Declaration 2016 (No 6).

## 2 Commencement

This instrument commences on the day after notification.

## 3 Notice of tax in arrears

The *Taxation Administration Act 1999*, (section 56I) provides for the Commissioner to declare the land tax and/or rates for a parcel of land are in arrears if the land tax and/or rates payable for that parcel of land have been in arrears for at least 1 year.
