#### 1. Name of Instrument

This instrument is the *Heavy Vehicle National Law (ACT) Access Canberra Delegation 2017 (No 1)*.

#### 2. Commencement

This instrument commences on 1 March 2017.

#### 3. Delegation

- I exercise the functions delegated to me under the National Heavy Vehicle Regulator Legislative Delegations, Delegation of Regulator's Functions Under the Heavy Vehicle National Law to the Director-General of Transport Canberra and City Services, Director-General of the Justice and Community Safety Directorate, and the Chief Operating Officer of Access Canberra, Australian Capital Territory, dated 20 February 2017.
- 2) For the purpose of giving effect to the Heavy Vehicle National Law in the Australian Capital Territory, I sub-delegate each function identified in column 4 of Schedule 1 to the persons holding or occupying from time to time the positions identified in column 2 of the Schedule, subject to the conditions (if any) specified in the corresponding column 5 of the Schedule.

Note: the persons identified are appropriately qualified employees of the Australian Capital Territory Public Service.

#### 4. Defined terms

The Dictionary in section 5 of the Heavy Vehicle National Law (Qld) provides definitions for this instrument.
