CANBERRA COMMUNITY HOSPITAL ORDINANCE 1958.

- 1.—(1.) This Ordinance may be cited as the Canberra Short title and Community Hospital Ordinance 1958.*
- (2.) The Canberra Community Hospital Ordinance 1938-1955† is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Canberra Community Hospital Ordinance* 1938-1958.

Definitions.

- 2. Section five of the Principal Ordinance is amended by omitting the definition of "services" and inserting in its stead the following definition:—
 - "'services' includes-
 - (a) the provision of drugs and dressings specified, from time to time, in the British Pharmacopæia or in the First and Second Schedules to the National Health (Pharmaceutical Benefits) Regulations, or of such other drugs or dressings as the Minister approves; and
 - (b) the provision of ambulance facilities;".

Revenue of the Board.

3. Section twenty-seven of the Principal Ordinance is amended by omitting from paragraph (c) the word "Hospital" (first occurring) and inserting in its stead the word "Board".

Expenditure by the Board.

- **4.** Section twenty-eight of the Principal Ordinance is amended by inserting, after paragraph (b), the following paragraph:—
 - " (ba) the payment of expenses incurred in the provision of ambulance facilities;".

Treatment.

- 5. Section thirty-two of the Principal Ordinance is amended—
 - (a) by omitting from paragraph (b) the word " and "; and
 - (b) by adding at the end thereof the following paragraph:—
 - "; and (d) such ambulance facilities as the Minister directs;".

Charges for treatment.

- 6. Section thirty-three of the Principal Ordinance is amended by inserting, after the word "treatment" in sub-section (1.), the words ", other than the provision of ambulance facilities."
- 7. After section thirty-six of the Principal Ordinance the following section is inserted:—

Charges for ambulance facilities.

- "36A.—(1.) The charges to be paid for ambulance facilities provided by the Board shall be as prescribed.
- "(2.) The provisions of sections thirty-four and thirty-six of this Ordinance apply to the charges prescribed under the last preceding sub-section in the same manner as they apply to the charges prescribed under section thirty-three of this Ordinance.".
