### SEAT OF GOVERNMENT (ADMINISTRATION) ORDINANCE 1972

1.—(1.) This Ordinance may be cited as the *Seat of Government (Administration) Ordinance 1972*.\*

(2.) The *Seat of Government (Administration) Ordinance 1930-1971*<sup>†</sup> is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Seat of Government (Administration) Ordinance 1930-1972*.
