Remuneration (Amendment) Ordinance 1986

An Ordinance to amend the Remuneration Ordinance 1976

Short Title

1. This Ordinance may be cited as the *Remuneration (Amendment)* Ordinance 1986.¹

Commencement

- **2.** (1) The provisions of this Ordinance other than section 5 shall come into operation on the day on which this Ordinance is notified in the *Gazette*.
 - (2) Sub-section 5 (1) shall come into operation on 29 May 1986.
 - (3) Sub-section 5 (2) shall be deemed to have come into operation on 1 July 1985.

Principal Ordinance

3. In this Ordinance, "Principal Ordinance" means the *Remuneration Ordinance* 1976.²

Interpretation

- **4.** Section 2 of the Principal Ordinance is amended—
 - (a) by omitting sub-section (1) and substituting the following sub-section:
 - "(1) In this Ordinance, unless the contrary intention appears—
 - 'prescribed authority' means a body declared by a law of the Territory to be a prescribed authority for the purposes of this Ordinance;
 - 'prescribed periods of engagement on authorised business', in relation to a member of a prescribed authority, means periods, each of which is a period of more than 1 hour in duration during which the member—
 - (a) was engaged in attending a meeting of the authority;
 - (b) was engaged, with the approval of the authority, on business of the authority; or
 - (c) was engaged, with the approval of the authority, in preparation for a meeting of the authority;

'relevant fee' means-

- (a) in relation to a member who is the chairman of a prescribed authority—\$169; and
- (b) in relation to a member of a prescribed authority, other than the chairman—\$136."; and
- (b) by omitting from paragraph (2) (a) "performing the duties of the chairman" and substituting "(however described) who presides at meetings".

Fees and allowances payable to members of a prescribed authority

- **5. (1)** Section 3 of the Principal Ordinance is amended by omitting subsections (3) to (7) (inclusive) and substituting the following sub-sections:
- "(3) Subject to this section, a member of a prescribed authority shall be paid the relevant fee in respect of—

- (a) each day on which the member is engaged in attending a meeting of the authority, being a meeting the duration of which on that day is not less than 3 hours;
- (b) each day on which the member is engaged, for a period on that day of not less than 3 hours, with the approval of the authority, on business of the authority; and
- (c) prescribed periods of engagement on authorized business where the aggregate of those periods is not less than 5 hours.
- "(4) Where a member of a prescribed authority is paid the relevant fee in respect of a day on which the member was engaged in the manner referred to in paragraph (3) (a), that member is not entitled to be paid the relevant fee—
 - (a) in respect of his or her engagement on that day in the manner referred to in paragraph (3) (b); or
 - (b) in respect of prescribed periods of engagement on authorized business where any of those periods includes any part of that day.
- "(5) Where a member of a prescribed authority is paid the relevant fee in respect of a day on which the member was engaged in the manner referred to in paragraph (3) (b), that member is not entitled to be paid the relevant fee—
 - (a) in respect of his or her engagement on that day in the manner referred to in paragraph (3) (a); or
 - (b) in respect of prescribed periods of engagement on authorized business where any of those periods includes any part of that day.
- "(6) Where a member of a prescribed authority is paid the relevant fee in respect of prescribed periods of engagement on authorised business, that member is not entitled to be paid the relevant fee in respect of a day on which the member was engaged in the manner referred to in paragraph (3) (a) or (b) if any part of that day was included in any of those periods.
- "(7) Where a member of a prescribed authority is paid the relevant fee in respect of prescribed periods of engagement on authorised business, that member is not entitled to be paid the relevant fee in respect of any other such periods where a part of any of those other periods includes part of any of the first-mentioned periods".
- (2) Section 3 of the Principal Ordinance is amended by omitting from subsection (8) "\$96" and "\$66" and substituting "\$110" and "\$85", respectively.

Adjustment of certain fees and allowances

- **6.** (1) The *Remuneration Ordinance 1976* as amended and in force from time to time shall, during a period specified in the Schedule, be taken to have had effect as if for the amount referred to in the provision of that Ordinance specified in Column 2 of an item in the Schedule there were substituted the amount specified in the column of that item in which that period is specified.
- (2) The *Remuneration Ordinance 1976* as amended and in force from time to time shall, during the period commencing on 1 July 1984 and ending at the expiration of 30 June 1985, be taken to have had effect as if for the amounts of \$96 and \$66 referred to in sub-section 3 (8) there were substituted the amounts of \$100 and \$80, respectively.
