FEDERAL CAPITAL COMMISSION.

REGULATIONS UNDER THE INDUSTRIAL BOARD ORDINANCE 1922-1926.

PURSUANT to the powers conferred upon it by the *Industrial Board Ordinance 1922-1926*, the Federal Capital Commission appointed under the *Seat of Government (Administration) Act 1924* hereby makes the following Regulations, to come into operation forthwith.

AMENDMENT OF INDUSTRIAL BOARD REGULATIONS.

1. Regulation 2 of the Industrial Board Regulations is amended ^{Definitions.} by inserting in the definition of "election", after the word "workmen" (secondly occurring), the words "or his deputy, as the case may be".

2. After regulation 3 of the Industrial Board Regulations, the following regulation is inserted:—

"3A.—(1.) Except where the office of the deputy of a member ^{Election of deputies.} is or becomes vacant for any reason other than the member ceasing to hold office—

- (a) the deputy of a member shall be elected at the election of the member;
- (b) no person shall be eligible for election as the deputy of a member unless he is a candidate for election as that member; and
- (c) every candidate for election as a member shall be deemed to be a candidate for election as the deputy of that member."

3. Regulation 6 of the Industrial Board Regulations is amended by ^{Nominations.} adding at the end of sub-regulation (3.) the words ", either as a member or as the deputy of that member; as the case requires".

Proceedings after nomination.

4. Regulation 7 of the Industrial Board Regulations is amended by adding at the end of sub-regulation (1.) the words "to be a member, if nominated for election as a member, or to be the deputy of that member, if nominated to be elected as the deputy of that member".

Form of ballot-paper.

5. Regulation 8 of the Industrial Board Regulations is amended—
(a) by inserting, after the word "Regulations" (first occurring), the words "for the election of a member and the deputy of that member"; and
(b) by adding at the end thereof the following sub-regulation:—
" (2.) The ballot-paper to be used at any poll taken in pursuance of those Regulations for the election of the deputy only of a member shall be in accordance with Form BA. in the Schedule to these Regulations and the voter shall record his vote in the manner set out therein".

Right to vote.

6. Regulation 9 of the Industrial Board Regulations is amended by adding at the end of sub-regulation (2.) the following proviso:—
" Provided that the election of a member and the election of the deputy of that member, if held on the same day, shall be deemed to be one election."

Polling and scrutiny.

7. After regulation 10 of the Industrial Board Regulations the following regulation is inserted: —

" 10A. Subject to these Regulations, the polling and scrutiny of ballot-papers shall be conducted as nearly as practicable, *mutatis mutandis*, in accordance with the provisions of the *Commonwealth Electoral Act 1918-1925*, and the regulations thereunder relating to the polling and the scrutiny at Senate elections as if the election of a member were an election to fill the first vacancy and the election of the deputy of the member were an election to fill the second vacancy in a Senate election:

Provided that the scrutiny of ballot-papers unenclosed in envelopes shall not be proceeded with until all the ballot-papers removed from envelopes in pursuance of sub-regulation (4.) of regulation 10 of these Regulations have been placed among them:

Provided further that the candidate who has received an absolute majority of votes on any count for electing a member shall be the candidate elected to be a member, and the candidate who has received an absolute majority of votes on any count for electing the deputy of that member shall be the candidate elected to be the deputy of that member."

Polling and scrutiny where deputy only to be elected.

8. Regulation 11 of the Industrial Board Regulations is amended—
(a) by adding at the commencement thereof the words "where the deputy only of a member is to be elected"; and
(b) by omitting the words "*Commonwealth Electoral Act 1918-1924*" and inserting in their stead the words "*Commonwealth Electoral Act, 1918-1925*".

Form A.

9. Form A in the Schedule to the Industrial Board Regulations is amended by inserting therein after the word "act" the words "as a member or the deputy of that member, as the case requires,".

Form B.

10. Form B. in the Schedule to the Industrial Board Regulations is amended by inserting after the word "Board" (secondly occurring), the words "and one Deputy of that member".

Form of ballot-paper for election of deputy only.

11. After Form B in the Schedule to the Industrial Board Regulations the following Form is inserted:—

Election of One Deputy of a Member of the Industrial Board by the workmen referred to in sub-section of section 3 of the Ordinance.

The elector shall mark his vote on this ballot-paper by placing the number 1 in the square opposite the name of the candidate for whom he votes as his first preference; and must give contingent votes for *all the remaining candidates* by placing the numbers, 2, 3, 4 (and so on, as the case requires) in the squares opposite their names, so as to indicate the order of his preference for them.

12. Form C in the Schedule to the Industrial Board Regulations is ^{Form C.} amended by inserting, after the word “Board” (fourthly occurring), the words “(or, as the case requires, the Deputy of a Member of the Industrial Board)”.
