MOTOR TRAFFIC REGULATIONS. 1. These Regulations may be cited as the Motor Traffic Regulations.

Short title Definitions

2. In these Rogulations, unless the contrary intention appears-

"Licence" means a licence under the Ordinance and includes a permitlicence :

3. Every application for the registration of a motor vehicle or the renewal

"Registration " means registration under the Ordinance ; "the Ordinance " means the Motor Traffic Ordinance 1926 ;

"the Schedule" means the Schedule to these Regulations.

Forms of application for registration or licence

or transfer thereof or for the grant of a licence or the renewal thereof shall be in accordance with the appropriate form in the Schedule. 4. A licence shall not be granted to any applicant unless a certificate of

competency, in accordance with Form 12 in the Schedule, has been given by a person thereto authorized by the Commission and the applicant has answered the questions prescribed in that Form and signed his name thereto.

Certificate of character.

5. Every application for the grant or renewal of a certificate relating to the issue of a trader's plate shall be in accordance with Form 19 or Form 20 in the Schedule, as the case requires.

6. A certificate in relation to the issue of a trader's plate shall not be granted unless a report in accordance with Form 21 in the Schedule recommending the issue of the trader's plate has been made by the person thereto authorized by the Commission.

7. (1) Where any certificate of registration or licence or certificate relating to the issue of a trader's plate has been lost, defaced or destroyed, the person to whom the certificate or licence was granted shall forward to the Commission a notification of the loss, defacement or destruction of the certificate or licence in accordance with Form 22 or Form 23 in the Schedule, as the case requires.

(2.) Where under section forty-four of the Ordinance, any person is required to forward to the Commission a statutory declaration, that person shall make a statutory declaration in accordance with Form 22 or Form 23 in the Schedule, as the case requires, and forward it to the Commission.

8. Where any number-plate issued under the Ordinance is defaced, the person to whom the number-plate was issued shall forward to the Com-mission a notification thereof in accordance with Form 24 in the Schedule.

9. (1) Where any number-plate issued under the Ordinance is lost or destroyed, the person to whom the number-plate was issued shall forward to the Commission a notification thereof in accordance with Form 25 in the Schedule

(2) Where, under section sixteen of the Ordinance, any person is required to forward to the Commission a statutory declaration, that person shall make a statutory declaration in accordance with Form 25 in the Schedule and forward it to the Commission.

10. A person shall not drive a public motor vehicle unless he has first submitted to the Commission a certificate of character in accordance with Form 26 in the Schedule, signed by two persons of good repute approved by the Commission or any delegate of the Commission, under the Ordinance.


