| Application for trader's plate.                          | 5. Every application for the grant or renewal of a certificate relating to the issue of a trader's plate shall be in accordance with Form 19 or Form 20 in the Schedule, as the case requires.   |
| Report on application for trader's plate.                | 6. A certificate in relation to the issue of a trader's plate shall not be granted unless a report in accordance with Form 21 in the Schedule recommending the issue of the trader's plate has been made by the person thereto authorized by the Commission.   |
