Regulations under the Industrial Board Ordinance 1936-1941.*

AMENDMENT OF THE INDUSTRIAL BOARD ELECTION REGULATIONS.

1. Regulation 2 of the Industrial Board Election Regulations is Definition of amended-

(a) by omitting the definition of "election" and inserting in its stead the following definition :---

- " election ' means the election of persons to be members of the Board, and deputies of those members, representing the employees specified in subsections (6.) and (7.) of section five of the Ordinance, respectively; "; and
- (b) by omitting from the definition of "the Ordinance" the figures "1936" and inserting in their stead the figures and words "1936-1941, as amended from time to time".

2. Regulation 5 of the Industrial Board Election Regulations is Preparation amended by omitting sub-regulation (3.) and inserting in its stead e following sub-regulation :---

"(3.) For the purposes of each election, after the first election, the representative of each organization shall furnish to the Returning Officer-

- (a) a list of members of the organization who have been employed in the Territory during the period of three months immediately preceding the appointed day but whose names do not appear on the roll prepared in respect of the election last preceding the appointed day; and
- (b) a list of members of the organization whose names appeared on the roll prepared in respect of the election last preceding the appointed day who have not been employed in the Territory during the three months immediately preceding the appointed day.".

Vote of person whose name is not on roll. **8. Regulation** 8 of the Industrial Board Election Regulations is **amended**—

(a) by omitting sub-regulation (1.) and inserting in its stead the following sub-regulation:—

"(1.) Notwithstanding anything contained in these Regulations, when any person who is an employee within the meaning of sub-section (6.) or sub-section (7.) of section five of the Ordinance claims to vote at an election and his name does not appear in the certified roll of voters, he may, subject to the Ordinance and these Regulations, be permitted to vote if he makes before the Returning Officer a declaration in accordance with Form A.";

- (b) by inserting in sub-regulations (2.) and (3.), after the word "ballot-paper" the words "(or ballot-papers)"
- (c) by inserting in sub-regulation (2.), after the word "it", the words "or them"; and
- (d) by inserting in sub-regulation (3.), after the word "it" (first occurring), the words "or them".

4. Regulation 9 of the Industrial Board Election Regulations is amended by omitting sub-regulations (2.) and (3.) and inserting in their stead the following sub-regulations:—

"(2.) Λ person cannot be nominated both as a member and as a deputy of a member and, if any such nominations are received, both nominations shall, subject to regulation 13 of these Regulations, be rejected.

"(3.) Nominations for the election of a member representative of employees specified in sub-section (6.) of section five of the Ordinance and a deputy of that member, or nominations for the election of a member representative of employees specified in sub-section (7.) of that section and a deputy of that member, shall be in accordance with Form B and shall be signed by the President or Chairman and the Secretary of the organization or local branch thereof of which the candidate is at the date of nomination a member and whose members are entitled to the benefit of a determination or industrial agreement made under the Ordinance.".

5. Regulation 16 of the Industrial Board Election Regulations is amended by omitting sub-regulations (2.), (3.) and (4.) and inserting in their stead the following sub-regulations:—

"(2.) A person who has, during the period of three months immediately preceding the appointed day, been employed in the Territory and who is a member or is eligible for membership of any of the organizations specified in the Second Schedule to the Ordinance may vote at the election of a member or a deputy of a member representative of the employees specified in sub-section (6.) of section five of the Ordinance, and not otherwise.

"(3.) A person who has, during the period of three months immediately preceding the appointed day, been employed in the Territory and who is a member or is eligible for membership of any organization, not being an organization specified in the Second Schedule to the

Ordinance, may vote at the election of a member or a deputy of a member representative of the employees specified in sub-section (7.) of section five of the Ordinance. and not otherwise.".

6. Regulation 18 of the Industrial Board Election Regulations is Voting papers to be amended by omitting sub-regulation (1.) and inserting in its stead the to be voters following sub-regulation :--

"(1.) As soon as practicable after the close of nominations for an election, the Returning Officer shall, if more than one candidate has been nominated, transmit to each voter whose name appears on the certified roll prepared in respect of that election, at the address set out in that roll, a ballot-paper for the election of a member and/or a ballot-paper for the election of a deputy of a member (as the case may be) representative of the employees specified in sub-section (6.) or sub-section (7.) of section five of the Ordinance, as the case requires, together with an envelope having printed thereon a form of declaration in accordance with Form C.".

7. Regulation 21 of the Industrial Board Election Regulations is Manner of voting repealed and the following regulation inserted in its stead :-

"21. Each voter shall record his vote on the ballot-paper in accordance with the directions set out thereon and shall send the ballotpaper, enclosed in the envelope bearing his declaration, by post or otherwise, to the Returning Officer to whom the envelope is addressed.".

8. Regulation 22 of the Industrial Board Election Regulations is Ballot-papers amended by inserting, after the word "ballot-paper" (wherever occur- or lost or ring), the words " (or ballot-papers)".

9. Regulation 26 of the Industrial Board Election Regulations is Scrutiny of votes and declaration. amended-

- (a) by inserting in paragraph (c), after the word "vote" (wherever occurring) the words "(or votes)";
- (b) by inserting in that paragraph, after the word "ballotpaper"; the words " (or ballot-papers)";
- (c) by inserting in paragraph (d), after the word "vote" (first and third occurring), the words "(or votes)";
- (d) by inserting in that paragraph, after the word "ballot-paper", the words "(or ballot-papers)";
- (e) by omitting paragraph (g) and inserting in its stead the following paragraph :---
 - "(g) Withdraw from each envelope the ballot-paper (or ballot-papers) contained therein and without unfolding the ballot-paper (or ballotpapers) or inspecting any vote thereon or permitting any other person to do so, place the ballot-paper (or ballot-papers) a on number corresponding with that placed on the envelope from which the ballot-paper was (or ballot-papers were) withdrawn and forthwith place the ballot-paper (or ballot-papers) in a locked and sealed ballot-box for further scrutiny;".

Further scrutiny.

10. Regulation 27 of the Industrial Board Election Regulations is amended-

(a) by omitting from sub-regulation (1.) all words from and including the words "In an election of a member" to the words "as follows :---", inclusive, and inserting in their stead the following words:-

"The Returning Officer shall open each ballot-box in which ballot-papers have been placed pursuant to paragraph (g) of the last preceding regulation and, after separating all the ballot-papers contained therein according to the particular election of a member or a deputy of a member, of the Board to which each such ballot-paper relates, shall conduct a further scrutiny in respect of each such election as follows:-";

(b) by omitting from sub-regulation (3.) the words "and the next succeeding regulation".

11. Regulation 27A of the Industrial Board Election Regulations Scrutiny where repealed. deputy is held at

the same time. 12. The Schedule to the Industrial Board Election Regulations is repealed and the following Schedule inserted in its stead :-

Penalty: Fifty pounds.

'38. A person shall not witness the signature of any person to any declaration under these Regulations unless-

- (a) he has satisfied himself as to the identity of that person;
- (b) he has seen the person sign the declaration in his own handwriting; and
- (c) he knows that the statements contained in the declaration are true. or has satisfied himself, by inquiry from the person, or otherwise, that the statements contained in the declaration are true.

Penalty: Fifty pounds.'.

Further Directions to Voter.
