## Regulations under the Building and Services Ordinance 1924-1942.\*

WILFRED SELWYN KENT HUGHES, Minister of State for the Interior, in pursuance of the powers conferred by the Building and Services Ordinance 1924-1942, hereby make the following Regulations.

## AMENDMENTS OF THE CANBERRA AND JERVIS BAY ELECTRIC SUPPLY REGULATIONS.

1. Regulation 6 of the Canberra and Jervis Bay Electric Supply Charges for Regulations is amended—

- (a) by omitting from sub-regulation (1.) the figures and words "1½d. per unit" and inserting in their stead the figures and words "13d, per unit";
- (b) by omitting from that sub-regulation the figures and words "10s. 2d. per quarter" and inserting in their stead the figures and words "15s, 0d. per quarter"; and
- (c) by omitting sub-regulation (2.).

2. Regulation 6A of the Canberra and Jervis Bay Electric Supply Charges for egulations is amended—

(a) by omitting paragraph (a) of sub-regulation (2.) and inserting in its stead the following paragraph:—

"(a) In the City Area and in a Rural Area-

For electricity used for lighting, other than shop window lighting, purposes-41d. per unit for all primary units, 34d. per unit for all secondary units, and 24d. per unit for all additional units, used during the month to which the reading

For electricity used for power and shop window lighting purposes-13d. per unit;";

domestic, church, rural and motion picture premises.

(b) by omitting paragraph (a) of sub-regulation (4.) and inserting in its stead the following paragraph:—

"(a) In the City Area and in a Rural Area—4<sup>1</sup>/<sub>4</sub>d. per unit for all primary units, and 1<sup>3</sup>/<sub>4</sub>d. per unit for all additional units, used during the quarter to which the reading relates;"; and

(c) by omitting from sub-regulation (6B.) the figures and words "1\frac{1}{4}d. per unit" and inserting in their stead the figures and words "1\frac{1}{2}d. per unit".

Hire of electric stoves and electric water heaters.

- 3. Regulation 6B of the Canberra and Jervis Bay Electric Supply Regulations is amended—
  - (a) by omitting from paragraph (c) the words "eightpence" and "fourpence" and inserting in their stead the words "One shilling" and "Six pence", respectively; and
  - (b) by omitting the figures and words " $1\frac{1}{2}$ d. per unit" (wherever occurring) and inserting in their stead the figures and words " $1\frac{3}{4}$ d. per unit".

**4.** The heading to the Schedules to the Canberra and Jervis Bay Electric Supply Regulations is amended by omitting the words "THE SCHEDULE." and inserting in their stead the words "THE SCHEDULES.".

- **5.** The First Schedule to the Canberra and Jervis Bay Electric Supply Regulations is amended—
  - (a) by omitting the words—

- (b) by omitting the words "Federal Capital Commission," and inserting in their stead the words "Department of the Interior,"; and
- (c) by omitting the words "Canberra Electric Supply Regulations" and inserting in their stead the words "Canberra and Jervis Bay Electric Supply Regulations".

The Second Schedule.

- 6. The Second Schedule to the Canberra and Jervis Bay Electric Supply Regulations is amended—
  - (a) by omitting the words—

(b) by omitting the words "Federal Capital Commission," (wherever occurring) and inserting in their stead the words "Department of the Interior,";

- (c) by omitting from Form A the words "Canberra Electric Supply Regulations" and inserting in their stead the words "Canberra and Jervis Bay Electric Supply Regulations";
- (d) by omitting from Form C the words "Canberra Electric Supply Regulations made under the Building and Services Ordinance 1924-1925" and inserting in their stead the words "Canberra and Jervis Bay Electric Supply Regulations made under the Building and Services Ordinance 1924-19
- 7.—(1.) Subject to the next succeeding sub-regulation, the charges Date from for the supply of electricity prescribed by regulations 6 and 6A of which amended the Canberra and Jervis Bay Electric Supply Regulations, as amended to operate by these Regulations, shall be payable in respect of the supply to a person of all electricity recorded by any reading made after the first day of June, 1952, of the meter or meters used for the purpose of ascertaining the quantity of electricity supplied to that person.

- (2.) The charges prescribed by regulation 6 of the Canberra and Jervis Bay Electric Supply Regulations, as amended by these Regulations, in respect of electricity in use in connexion with a hot water system shall be payable from and including the first day of June, 1952.
- (3.) The terms of any agreement in respect of the hire of apparatus under regulation 6B of the Canberra and Jervis Bay Electric Supply Regulations in force on the first day of June, 1952, shall be deemed to be amended from and including that date to provide for payment of charges in respect of that hire in accordance with that regulation as amended by these Regulations.
