

# ADVISORY COUNCIL ORDINANCE

## ADVISORY COUNCIL ELECTION REGULATIONS\*

### REGULATIONS 1967, No. 8†

1. Regulation 4 of the Advisory Council Election Regulations is amended by omitting the figures "218". Provisions of Commonwealth Electoral Act that do not apply.
2. Regulation 4A of the Advisory Council Election Regulations is amended by omitting sub-paragraph (ii) of paragraph (b) of sub-section (1.) and inserting in its stead the following sub-paragraph:—  
    "(ii) the words "Two hundred dollars" were omitted from sub-paragraph (i) of paragraph (c) and the words "Ten dollars" inserted in their stead;". Modifications of the Commonwealth Electoral Act in its application to Advisory Council elections.
3. Regulation 65 of the Advisory Council Election Regulations is repealed. Preservation of ballot-papers.
4. Form 6 in the Schedule to the Advisory Council Election Regulations is amended by omitting the words "a State, for the Australian Capital Territory or for the Northern Territory of Australia" and inserting in their stead the words "the Australian Capital Territory, for a State or for the Northern Territory or, where the applicant is outside Australia, an Officer of the Naval, Military or Air Forces of the Commonwealth or of some other part of the Queen's dominions, a person employed in the Public Service of the Commonwealth, a Territory of the Commonwealth or a part of the Queen's dominions or a Justice of the Peace for, or a minister of religion or medical practitioner resident in, a Territory of the Commonwealth or a part of the Queen's dominions". Form 6.
5. Form 15 in the Schedule to the Advisory Council Election Regulations is amended by omitting the words "an elector whose name appears on the Roll for a State, for the Australian Capital Territory or for the Northern Territory of Australia" and inserting in their stead the words "a person whose name appears on the Roll of electors for the Australian Capital Territory, for a State or for the Northern Territory, or a person entitled to be enrolled on such a Roll". Form 15.
6. Form 17 in the Schedule to the Advisory Council Election Regulations is amended by omitting the words "an elector whose name appears on the Roll for a State, for the Australian Capital Territory or for the Northern Territory of Australia" and inserting in their stead the words "a person whose name appears on the Roll of electors for the Australian Capital Territory, for a State or for the Northern Territory, or a person entitled to be enrolled on such a Roll". Form 17.
7. The Advisory Council Election Regulations are further amended as set out in the Schedule to these Regulations. Additional amendments.
