# Health Commission (Charges) Regulations<sup>2</sup> (Amendment)

## Repeal of regulation 8

1. Regulation 8 of the Health Commission (Charges) Regulations is repealed.

## Prescribed classes of persons for the purposes of sub-section 74 (3) of the Ordinance

2. Regulation 9 of the Health Commission (Charges) Regulations is amended by omitting from paragraph (2) (b) "or 'notifiable disease'".

## Repeal of Schedule

3. The Schedule to the Health Commission (Charges) Regulations is repealed.
