**Motor Omnibus Fares Regulations<sup>2</sup>**  
**(Amendment)**

I, THOMAS UREN, the Minister of State for Territories and Local Government, hereby make the following Regulations under the *Motor Omnibus Services Ordinance 1955*.

**Exemptions**

1. Regulation 10 of the Motor Omnibus Fares Regulations is amended by omitting from sub-regulation (1) "6 or 9" and substituting "9, 11 or 11A".

2. After regulation 11 of the Motor Omnibus Fares Regulations the following regulation is inserted:

**Concession fares—Wednesdays**

"11A. Notwithstanding the provisions of regulation 4, the fare to be charged in respect of a journey—

(a) that commences between the hours of 9 o'clock in the morning and 3 o'clock in the afternoon, or after 6 o'clock in the evening, on a Wednesday; and

(b) that is undertaken by a pensioner, an unemployed person, a special beneficiary or a dependent spouse,

is 10 cents."

3. The Motor Omnibus Fares Regulations are amended as set out in the Schedule.
