About this republication

The republished law

This is a republication of the *Bail Regulation 1992*, made under the *Bail Act 1992* (including any amendment made under the *Legislation Act 2001*, part 11.3 (Editorial changes)) as in force on 2 November 2004. It also includes any amendment, repeal or expiry affecting the republished law to 2 November 2004.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the *Legislation Act 2001* applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

Editorial changes

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication includes amendments made under part 11.3 (see endnote 1).

Uncommenced provisions and amendments

If a provision of the republished law has not commenced or is affected by an uncommenced amendment, the symbol $\boxed{\mathbf{U}}$ appears immediately before the provision heading. The text of the uncommenced provision or amendment appears only in the last endnote.

Modifications

If a provision of the republished law is affected by a current modification, the symbol **M** appears immediately before the provision heading. The text of the modifying provision appears in the endnotes. For the legal status of modifications, see *Legislation Act 2001*, section 95.

Penalties

The value of a penalty unit for an offence against this republished law at the republication date is—

- (a) if the person charged is an individual—\$100; or
- (b) if the person charged is a corporation—\$500.

1 Name of regulation

This regulation is the *Bail Regulation 1992*.

4 Service of notice under Act, s 34 (4) (c)

A notice under the Act, section 34 (4) (c) advising an accused person of the place, date and time to which proceedings are adjourned or postponed must be given or sent to the accused person by giving the notice to him or her or by leaving the notice at his or her last-known or usual place of residence or business with a person who is apparently resident or employed at that place and apparently over 16 years old.

5 Request for review under Act, div 6.1

A request under the Act, section 38 for the review of a decision relating to bail for an accused person may be made—

- (a) by the accused person or a representative of the accused person; and
- (b) either orally or in writing.

6 Limitations on applications for review of bail decisions

- (1) An accused person may not make more than 1 application under the Act, section 38 for the review of a decision relating to bail on the same grounds.
- (2) An accused person may not apply under the Act, section 38 for the review of a decision relating to bail if the conducting of the review would prevent the accused person from attending court as required in relation to an offence with which he or she has been charged.
